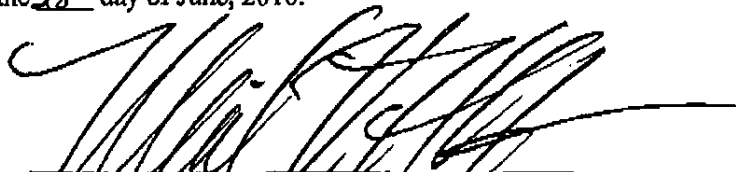
ARTICLE 6
