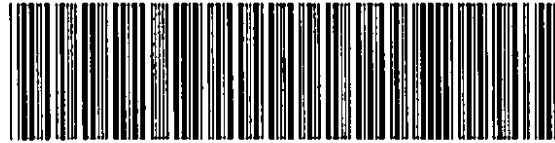

The undersigned, for the purpose of amending and re-stating the original Articles of Organization drafted and submitted under the Florida Revised Limited Liability Company Act, *F. S. Ch. 605*, hereby make, acknowledge, and file the following Amended and Restated Articles of Organization pursuant to Fla. Stat. § 605.0202:

**ARTICLE I**

The name of the limited liability company is **TOMAHAWK BATS, LLC** (the "Company").

**ARTICLE II**

The mailing address and the street address of the Company shall be **1152 N. Scenic Hwy., Lake Wales, FL 33853**.

**ARTICLE III**

The Articles of Organization were filed with the Florida Department of State, Division of Corporations on June 30, 2016. The Effective Date of this Amended and Restated Articles of Organization shall be the date of filing with the Florida Department of State, Division of Corporations.

**ARTICLE IV**

The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the Articles of Organization.

**ARTICLE V**

#### ARTICLE VII

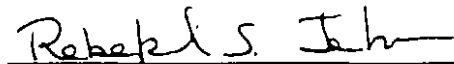

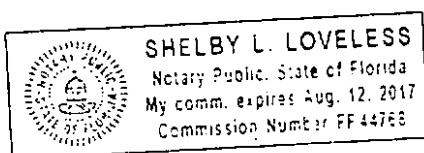
