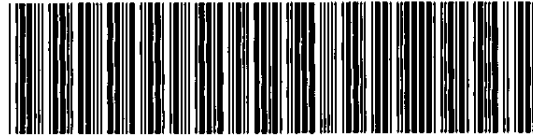

THIRD: The mailing address and street address of the principal office of the Limited Liability Company is 2942 Aqua Virgo Loop, Orlando, FL 32837.






