I am the President and Owner of Shiny Happy Houses, Inc., Document #P16000051513, filed 6/13/16.

I am also the Sole and Managing Member of Shiny Happy Houses, LLC, filed June 23, 2016, Tracking #500287065755.

On June 13, 2016, I registered Shiny Happy Houses, Inc. as a Florida Corporation.
