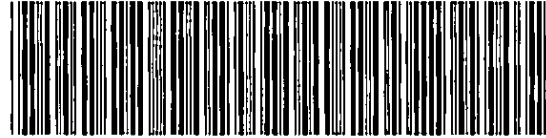




ARTICLE I - ORGANIZATION NAME




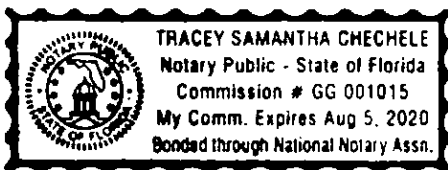
