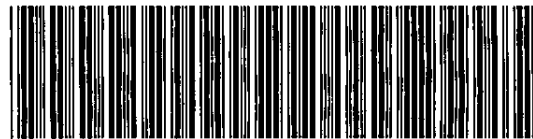



SECOND: The management of the limited liability company is reserved for the members, and the names and addresses of the members are:


