C. Article V is hereby amended to reflect that the current address of the registered agent of the Company is 342 Linda Lane NW, Fort Walton Beach, Florida 32548.


D. Article VI is hereby amended to reflect that the current address of the manager of the Company is 342 Linda Lane NW, Fort Walton Beach, Florida 32548.
