- (d) the occurrence of any involuntary transfer of his membership interest in the Company, the effect of which is to vest any legal or equitable interest in such membership interest in some person other than the member.

Upon the occurrence of a Disqualifying Event, the Disqualified Member shall sever all employment with, and forthwith cease to be a member of, the Company and, except to receive payment for his membership interest in accordance with the foregoing, and payment of any other sums then lawfully due and owing to the Disqualified Member by the Company, the Disqualified Member shall then and thereafter have no further financial interest of any kind in the Company. Each member of the Company hereby grants an irrevocable power of attorney to the Company to cancel his entire membership interest in the Company upon the occurrence of a Disqualifying Event.
