**ARTICLES OF ORGANIZATION

The undersigned, George Coors Arthur and Michelle Richmond Arthur, natural persons competent to contract and an authorized representative of Ruthra Retreat, LLC, hereby present these Articles of Organization as the Articles of Organization of Ruthra Retreat, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Ruthra Retreat, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**


**ARTICLE VI - MANAGEMENT**




