**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
LWR LAND HOLDINGS, LLC**

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **LWR LAND HOLDINGS, LLC** adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is LWR Land Holdings, LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on July 14, 2016, under Document Number L16000130036.


THIRD: The following amendment to the Articles of Organization is hereby adopted by the Company:
