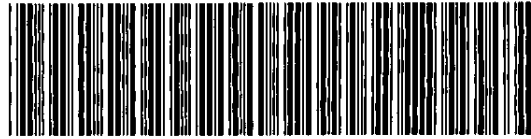

**ARTICLES OF ORGANIZATION

ARTICLE VI - NEW MEMBERS




