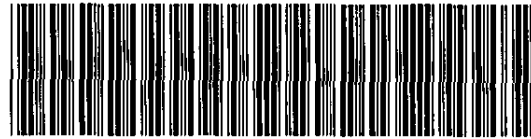



The name of the Limited Liability Company is: 2401 SE 7TH DRIVE, LLC.”

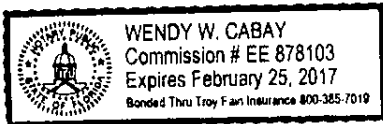
