ARTICLES OF ORGANIZATION
OF
ECHTRALEX SERVICES, LLC

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 605 of the Florida Statutes (the "Act").

1. **NAME.** The name of this limited liability company (the "Company") is ECHTRALEX SERVICES, LLC.

2. **EFFECTIVE DATE AND DURATION.** The existence of the Company shall commence on July 18, 2016. The period of duration of the Company shall be perpetual.

3. **PURPOSE.** The purpose and business of the Company shall be to engage in any lawful act or activity which may be carried on by a limited liability company under the Act.

4. **MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE.** The mailing address and street address of the principal office of the Company is: 4003 Longfellow St., Hyattsville, MD 20781.

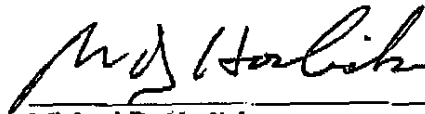

9. RESTRICTIONS ON TRANSFER OF MEMBERSHIP INTERESTS. The governance rights which are attributable to Membership Interests in the Company may not be transferred. Distributional rights which are attributable to Membership Interests may only be transferred in compliance with the restrictions set forth in the Operating Agreement of the Company. Any attempted transfer in violation of such restrictions shall be void ab initio and of no legal force or effect.

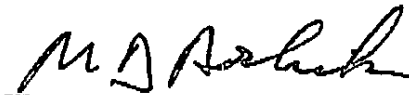
