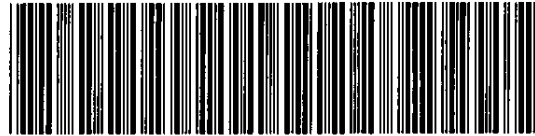

The name of the limited liability company is: 640 Ocean, LLC.


ARTICLE II. ADDRESS
