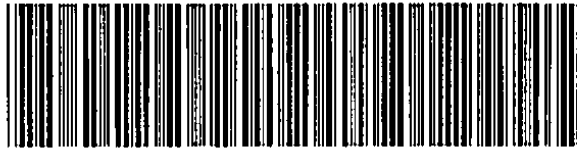

I wanted to change the name of this LLC to Sarasota Reef Charters but rather than amend this LLC, I mistakenly formed a new LLC called Sarasota Reef Charters (L19000188073 Filed July 22, 2019). In consultation with your office, I was advised to dissolve the new LLC and then I could amend the original LLC name to what had been the new LLC name. I was told that dissolved LLC names were held for a period before they would be available for others to select. I officially dissolved Sarasota Reef Charters, LLC (L19000188073) on December 4, 2019 and have attached the dissolution filing receipt. As such, the name "Sarasota Reef Charters, LLC" should now be available to use and replace the name "Boat for Hire of Sarasota, LLC" via this amendment.
