**ARTICLES OF ORGANIZATION

ARTICLE I

The name of this Limited Liability Company is: CGR Services Group LLC (hereinafter referred to as the "Company").

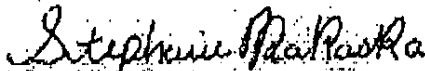
