**ARTICLES OF ORGANIZATION  
OF  
SURGCATH, LLC**

The undersigned, for purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I - NAME**

The name of this limited liability company shall be SURGCATH, LLC ("LLC").

**ARTICLE II - ADDRESS**

**ARTICLE III - DURATION AND PURPOSE**

**ARTICLE V – ADMISSION OF NEW MEMBERS**
