ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
PADDOCK RIDGE MEMORY CARE, LLC

The undersigned, being a Manager of Paddock Ridge Memory Care, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is Paddock Ridge Memory Care, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective July 25, 2016, and the Florida document number assigned to this Company is L16000138062.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:
