

ARTICLES OF AMENDMENT

AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF ANCHOR OF OCALA, LLC



The undersigned, for the purpose of forming a multi-member limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I NAME AND ADDRESS
