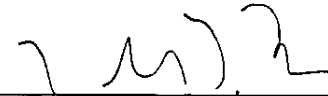

The name of the limited liability company is: ONE SHOP WIRELESS, LLC.

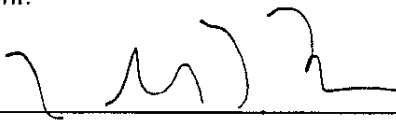
ARTICLE II. ADDRESS

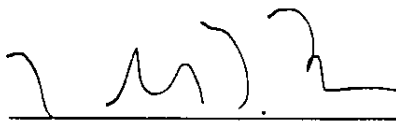
