

AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR

HARBOR CONFLUENT INVESTMENT, LLC a Florida Limited Liability Company

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned has executed and hereby files the following Amended and Restated Articles of Organization for such limited liability company.

The present name of the limited liability company is HARBOR CONFLUENT INVESTMENT, LLC (the "Company"); the date of filing of its original Articles of Organization with the Florida Department of State was July 28, 2016 and assigned Florida document number L16000140008.

ARTICLE I. NAME
