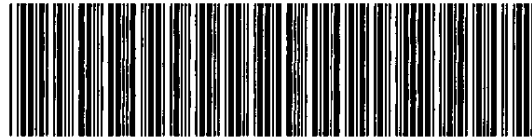

The name of the Limited Liability Company is LIFE HAPPENS COUNSELING & WELLNESS, LLC.






