AMENDED & RESTATED ARTICLES OF ORGANIZATION FOR VB102, LLC

The undersigned certifies that these Amended & Restated Articles of Organization are submitted to the Florida Department of State for the purpose of amending and restating the original Articles of Organization filed with the Florida Secretary of State on July 26, 2016 [Florida document number L16000140643].

ARTICLE I. NAME & PRINCIPAL PLACE OF BUSINESS

- 1. Name: The name of the limited liability company shall be VB102, LLC.
- 2. **Principal Address:** Its principal office shall be located at <u>2900 NE 22ND COURT</u> <u>POMPANO BEACH, FL 33062</u>, but it shall have the power and authority to establish branch offices at any other place or places as the Manger may designate.
- 3. *Mailing Address:* Its mailing address shall be <u>2900 NE 22ND COURT POMPANO BEACH, FL 33062.</u>

ARTICLE II. PURPOSES & POWERS

- 6.
