The undersigned, Elizabeth Santelises, declares that I am over the age of 18, and a resident of Orange County State of Florida.


This affidavit is being sent at the request of the Recording Division of Corporations Florida Department of State regarding the denial of my application due to the use of the word Disney on the title.
