Operating Agreement

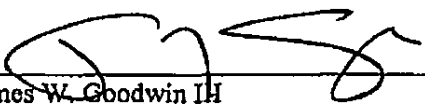

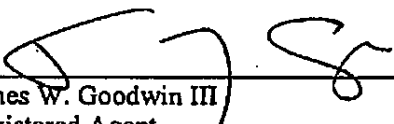
