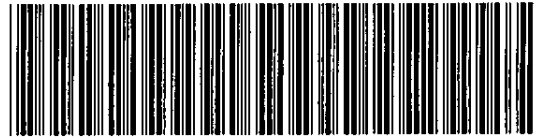

The Company shall commence its existence on the date that these Articles are filed with the Department of State, and its duration shall be perpetual unless sooner dissolved by law.

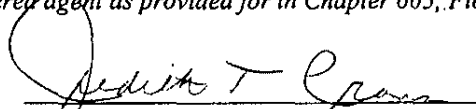
ARTICLE IV - Management

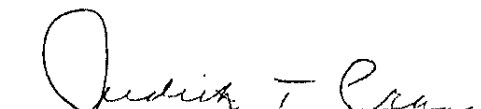
ARTICLE V - Registered Agent and Acceptance of Appointment of Registered Agent
