ARTICLES OF ORGANIZATION OF FREELAND COMMERCIAL REALTY, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization.

ARTICLE I

The name of the Limited Liability Company shall be Freeland Commercial Realty, LLC.

ARTICLE II ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is 2038 Forbes Street, Jacksonville, Florida 32204.

ARTICLE III PURPOSE

ARTICLE VII ADOPTION OF OPERATING AGREEMENT

The Company shall adopt an Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization or Chapter 605, Fla. Stat.

ARTICLE VIII REGISTERED AGENT AND OFFICE

The Company designates 2038 Forbes Street, Jacksonville, Florida 32204, as the street address of the initial registered office of the Company and names Robert C. Freeland, as the Company's initial registered agent at that address to accept service of process within this State.

ARTICLE IX CONTINUATION OF BUSINESS

Unless dissolved in accordance with the Company's Operating Agreement, the remaining Members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member.
