

## ARTICLES OF ORGANIZATION OF RICHARD AND DON LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 805, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

# ARTICLE I - NAME
