

I found out about this because I received a letter addressed to Evolve Light LLC at my home address. I went to your website and found the electronic articles of organization for this LLC. I have not formed a LLC in the state of Florida and I know nothing about this company. I preface this because the form you sent me to fill out is a Dissociation or Resignation of Member, Manager from Florida or Foreign LLC. I was never involved in this LLC and I want my name taken off, so I am enclosing the \$25 filing fee. As I stated, this is a fraud and I would like this matter referred to the Florida State Attorney. I am probably not the only victim of this scam.

After doing a little research into this company, I found the mailing address is a mailbox rental at Parcels Plus in Pompano Beach, Florida. I found Evolve Light's website: <https://evolvelight.com> and tried to call their main phone number, which has a Tampa area code: 813-337-0077 and found a recorded message saying the voice mail box is full and then it hung up on me. My fear is people will start contacting me about this company. I would appreciate a quick response to this issue.
