



ARTICLES OF ORGANIZATION

GANTT DISTRICT NETWORK OFFICE, L.L.C.

The undersigned, under the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

Article I. Name

The name of this limited liability company is Gantt District Network Office, L.L.C. ("the Company").

Article II. Duration

Unless earlier terminated under the law or the Operating Agreement, the duration of the Company shall be perpetual.

Article III. Address of Principal Office

The street address and the mailing address of the principal office of the Company is 2039 Centre Pointe Boulevard, Suite 101, Tallahassee, Florida 32308.

Article IV. Initial Registered Agent and Address
