The name of the Company is SSL PC MANAGEMENT LLC.

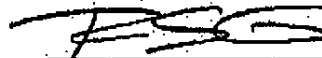

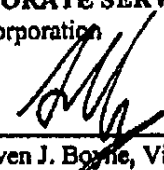
