ARTICLES OF ORGANIZATION
OF
SCALISE FAMILY HOLDING COMPANY SEVEN, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following *Articles of Organization*.

ARTICLE I – NAME

The name of the limited liability company shall be **SCALISE FAMILY HOLDING COMPANY SEVEN, LLC** (“company”).

ARTICLE II – ADDRESS

The mailing address and the street address of the principal office of the company is 240 London Drive, Palm Coast, Florida 32137.

ARTICLE III – DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The company’s existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE VI – ADDITIONAL CAPITAL CONTRIBUTIONS

Members may make additional capital contributions to the company on the consent of the Managing Members, or as provided in the Operating Agreement.

ARTICLE VII – TRANSFER DURING LIFE

No member shall sell, assign, pledge or otherwise transfer, pledge or encumber, in any manner or by any means whatever, any interest in all or part of his capital contribution in the company (hereinafter referred to as transfer) except upon approval of the Managing Members.

ARTICLE VIII – ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the written consent of the Managing Members of the company and on such terms and conditions as shall be determined by the Managing Members. A member may not transfer his or her interest in the company except as set forth in the Operating Agreement of the company, and no transferee shall have the right to participate in the management of the business and affairs of the company or become a member unless the Managing Members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.


ARTICLE IX - MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall not be dissolved on the death, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is terminated by majority vote of all the remaining members.

ARTICLE X - MANAGEMENT

The company shall be managed by the Members in accordance with regulations adopted by the members and as set out in the Operating Agreement for the management of the business and affairs of the company. These regulations may contain any provisions for the management of the affairs of the company not inconsistent with law or these Articles of Organization.

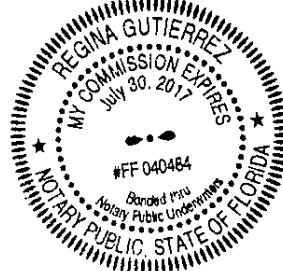


