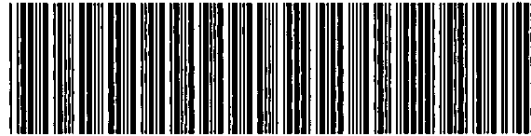



The name of the Florida Limited Liability Company is **Inagua Way Rental LLC**.




