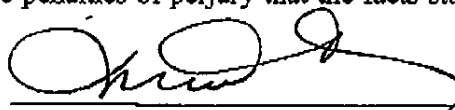

**ARTICLES OF ORGANIZATION  
OF  
BISSETT-HAYES MCGRATH DILLON, LLC**

1. **NAME.** The name of this limited liability company is BISSETT-HAYES MCGRATH DILLON, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
2. **PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 2210 South U.S. Highway 301, Suite 100, Tampa, Florida 33619.
3. **REGISTERED AGENT AND OFFICE.** The name of the initial registered agent of the Company is Preston O. Cockey, Jr. The street address of the initial registered agent of the Company is 110 E. Madison Street, Suite 204, Tampa, Florida 33602.
4. **MANAGEMENT OF THE COMPANY.** The Company shall be managed by a manager or managers in accordance with the Operating Agreement adopted by all of the members and is, therefore, a **manager-managed** company. The initial manager of the Company is Courtney Bissett-Hayes.
5. **OPERATING AGREEMENT.** The Members of the Company shall have the power to adopt, alter, or amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

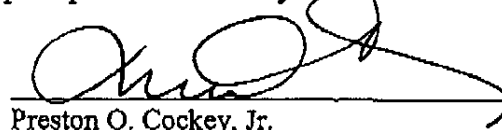
