**ARTICLES OF ORGANIZATION  
OF

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is HSC LATAM, LLC (the "Company").

**ARTICLE II. ADDRESS**

The principal and mailing address office of the Company is 300 International Parkway, Sunrise, FL 33325.

**ARTICLE III. REGISTERED AGENT AND OFFICE**


**ARTICLE VII. ADDITIONAL MEMBERS**


