**ARTICLES OF ORGANIZATION  
OF

The undersigned, Tom Anderson, a natural person competent to contract and an authorized representative of CANVAS 30A, LLC, hereby presents these Articles of Organization as the Articles of Organization of CANVAS 30A, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is CANVAS 30A, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The street and mailing address of the Company's initial principal office is 17 Topside Row, Woodlands, Texas 77380. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

**ARTICLE III - PURPOSE AND POWERS**


