ARTICLE VIII - CAPITAL CONTRIBUTIONS


The members of the company shall contribute to the capital of the company.



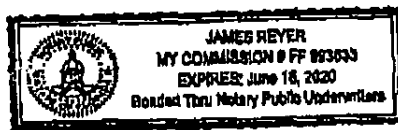


