**ARTICLES OF ORGANIZATION
OF
WESTCOAST MOTORSPORTS LLC**

The undersigned authorized member hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

**ARTICLE I
Name**

The name of this professional limited liability company (the "Company") shall be:

WESTCOAST MOTORSPORTS LLC

**ARTICLE II
Principal Office and Mailing Address**

The address of the principal office and the mailing address of the Company shall be:

1950 Magnolia Drive
Clearwater, FL 33764

**ARTICLE III
Registered Office and Registered Agent**

The initial registered office of the Company shall be located at 1950 Magnolia Drive Clearwater, FL 33764, and the initial registered agent of the Company at such office shall be DONALD E. ONDREJCAK SR. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

**ARTICLE IV
Business and Purposes**

The general nature of the business to be transacted by the Company, or the objects or purposes of the Company, shall be as follows:

(a) to engage specifically in the business of buying and selling new and refurbished performance and stock automotive parts and components, and the rendering of related transactions as may be required from time to time to perform its business operations including the buying and selling of motor vehicles, unregistered and registered.

(b) to invest in real estate, mortgages, stocks, bonds, any other type of investments.

(c) to own or lease real and personal property necessary for the rendering of the ongoing business of this entity.

(d) to borrow money and contract debts when necessary for the transaction of its business or for the exercise of its rights, privileges or franchises, or for other lawful purposes; to issue promissory notes and other obligations and evidences of indebtedness payable at a specified time or times and secured by mortgages or otherwise; and

(e) in general, to have and exercise all powers conferred by the laws of Florida upon limited liability companies, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

ARTICLE V **Management**

The Company is a member-managed limited liability company structured with officers assigned specific duties and an advisory board of directors. The name and street address of the "AMBR" of the Company shall be:

ARTICLE VI **Operating Agreement**

The operating agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the laws of the State of Florida or of the United States.

ARTICLE VII **Amendment of Articles of Organization**

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
