# ARTICLES OF ORGANIZATION OF WINTER GOOSE PRODUCTIONS LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

#### ARTICLE I. NAME

The name of the limited liability company is Winter Goose Productions LLC (the "Company").

#### ARTICLE II. MAILING AND STREET ADDRESS

The mailing and principal office address of the Company shall be 8323 Lake Crowell Circle, Orlando, Florida 32836.

#### ARTICLE III. PURPOSE

The purpose of the Company is to engage in (i) media production, editing, distribution and streaming, (ii) entertainment consulting, and (iii) any other activities or business permitted under the Laws of the United States and Florida.
