ARTICLES OF ORGANIZATION

ARTICLE I
Name of Limited Liability Company

The name of this limited liability company is KAREN DILLS CONSULTING, LLC (the "Company"), with its principal place of business being located at 4927 Kensington Park Blvd., Orlando, Florida 32819 and the mailing address is the same.

ARTICLE II
Duration

ARTICLE III
Purpose

ARTICLE VII
Management of the Company

Transfer of Interest

If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring members shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

ARTICLE XI
Certificated Interests

The members' interests in the Company shall be evidenced by certificates.

ARTICLE XII
Contracting Debts

All contracting debts of the limited liability company require the approval of one of the managers.


