ARTICLES OF ORGANIZATION
OF WFP LARGO, LLC

The undersigned authorized representative of a Member of a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby submit the following Articles of Organization:

ARTICLE I. NAME - The name of the company shall be WFP Largo, LLC.

ARTICLE II. DURATION - The period of the Company's duration shall commence on the date of filing of these Articles of Organization and shall exist perpetually, unless terminated in accordance with the Company's operating agreement.


