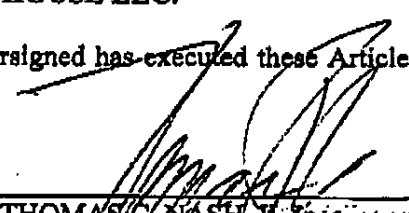
ARTICLE VIII
