My name is Abigale Weech-Starkey and I am the owner of Chop Shop, a restaurant in Lakeland, FL. In 2014, I hired a bookkeeper who suggested I should not be operating as a sole proprietor. Instead of setting up an LLC, she filed as Rebel Alliance Inc on 3/15/14. While she did set up a new EIN, all of my payroll taxes have been filed under my EIN as a sole-proprietor and the corporation has never been active. The corporation was administratively dissolved on 9/25/15. My new bookkeeper started over with a brand-new filing as Rebel Alliance LLC on 7/7/16 to be effective 7/1/16.

Unbeknownst to me, the LLC filing was rejected because a full year had not passed since the corporation had been dissolved. Therefore, I am writing to notify the department that I will not be reinstating Rebel Alliance Inc. and hereby release the name Rebel Alliance to be used in my new company, Rebel Alliance LLC, effective July 1, 2016.
