The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

ARTICLE I - NAME

The name of the Company shall be BEN DODARELL MARINE, LLC.

<u>ARTICLE II - PURPOSE</u>

This Company is formed to provide marine services, including marine survey, naval architecture, consulting, repair, restoration and maintenance of vessels, and to sell marine products to supplement such services.
