**SECOND ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION
PDI NYC ELECTRIC, LLC**

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of PDI NYC ELECTRIC, LLC, a Florida limited liability company (the "Company"), are hereby amended as follows:


1. The name of the company is PDI NYC ELECTRIC, LLC.
2. The Articles of Organization of the Company were filed with the office of the Florida Department of State on August 22, 2016, and assigned document number L16000155875. The Articles of Organization were subsequently amended on February 23, 2018.
3. Article 8 of the Articles of Organization of the Company is hereby amended to read in its entirety as follows:
