ARTICLE II - PRINCIPAL OFFICE


The mailing address and street address of the principal office of the Company is 265 Drivers Way, Hardeeville, South Carolina 29927.

ARTICLE IV - MANAGEMENT


The Company is a manager-managed limited liability company and the initial manager of the Company is Coastal States Automotive Group, LLC, a Florida limited liability company.
