The Articles of Organization of PA Italian Imports, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on August 24, 2016 under Document Number L16000157881, and amended on May 25, 2017. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is PA Italian Imports, LLC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address and the street address of the principal office of the Company is 265 Drivers Way, Hardeeville, South Carolina 29927.


ARTICLE III - REGISTERED OFFICE AND AGENT


