AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF 1945 STATE STREET LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of 1945 State Street LLC, originally filed on August 24, 2016, are amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the limited liability company is 5102 Sunderland Road LLC (the "Company").
