**ARTICLES OF ORGANIZATION
OF
MARAJ FAMILY, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is MARAJ FAMILY, LLC (the "Company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The Company shall terminate on December 31, 2050, unless sooner dissolved as required by statute.


