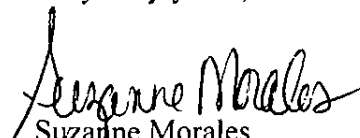

ARTICLES OF ORGANIZATION
MILLER STREET CONDOS, LLC
A LIMITED LIABILITY COMPANY

1. **Name.** The name of the limited liability company is MILLER STREET CONDOS, LLC.
